Use of Computers and Internet Agreement – 2017

A. General

Northpine Christian College is pleased to offer students access to computers and associated network equipment. The aim of the College is to provide the best possible environment to encourage our students to become competent, effective and responsible users of technology. It is our intention that these resources are to be available equally to all members of our community and are to be used for educational purposes.

Students who wish to gain access to the network must sign this form indicating that they agree to abide by the network rules and also obtain parental permission as the network also includes the Internet, which is beyond the boundaries of the College. Should a parent prefer that a student not have e-mail and Internet access, use of the computers is still possible for more traditional purposes such as word processing. This document is to be renewed on an annual basis.

B. What is expected?

Students are responsible for appropriate behavior while using College computers, just as they are when using any classroom or playground equipment. Communications on the network are often public in nature. General College rules for behavior and communication apply. It is expected that users will comply with Christian standards and the specific rules that are found on the College support pages (a printed copy is available upon request). The use of the College's computers is a privilege, not a right, and may be revoked if abused. The user is personally responsible for his/her actions in accessing and utilizing the College's computer resources. The students are advised never to access, keep, or send anything that they would not want their parents or teachers to see.

C. Student Responsibilities

I understand that the College network is a useful tool that can help me in my learning. I am aware of the rules I need to keep (found on the College support page). In particular I understand that I cannot share my user name and password with anyone, because if anyone uses my username to do inappropriate things I will be held responsible.

If my parents/guardian gives me permission to use the Internet, while I have access to the Internet:

- I will use the Internet and my email account (Year 5 and 6) only as the teacher directs me to.
- I understand that I am responsible for the laptop issued to me during class. I will take care of the laptop and make sure it is returned in the same condition it was issued to me.
- I will not look for or access anything that is illegal, dangerous or offensive.
- I will not try to get into any pages that are blocked by the College.
- If I accidentally come across something that is illegal, dangerous or offensive, I will:
 1. close the lid of my computer
 2. immediately and quietly inform my teacher
 3. clear any offensive pictures or information from my screen.
- I will not give out any personal details belonging to me or anyone else (phone numbers/addresses etc).
- I will not use the Internet to annoy or offend anyone else.

I understand that if the school decides I have broken the rules, I may need to face consequences. This may mean that I can't use the internet or computers for a time. As a user of the College computers, I agree to follow the rules and to use the computers in a constructive way.
